- International (\$56.00) - Subscribing membership not served by U.S. Postal Service. Includes immediate access to SCA electronic newsletters and publications. Printed publications may be purchased for an additional cost.
Associate (\$40.00) - Membership only. Associate members may not purchase printed or electronic subscriptions.
Family (\$15.00 each) - One additional adult and any children age 21 and under, residing at the same address as an International Member. Family Members have the privileges of Associate Membership. A maximum of \$45 will be collected for family members. NOTE: Submit a separate form for each Family Member. Complete sections 1, 2, and 3 of each form.
